Following a pursuit of a confirmed stolen vehicle in which he was the passenger (2017 Toyota Rav4 VIN 2T3DFREV9HW629174), stolen under Seattle PD #19-337341, Tremaine was taken into custody. A computer check returned an active misdemeanor warrant for his arrest, #990420549, \$500 for Prop Dest. Post-Miranda, Tremaine denied ownership of any property from within the car. Consent to search was given by the RO at the time of report. **A firearm was recovered from under Tremaine's seat.** A computer check of the serial number GKS0028586, returned report of **stolen out of Seattle (19-330465).** His girlfriend, Linda Jimmy, was arrested as the driver. **Tremaine told me he had stolen the car around a week prior, in Seattle and observed the keys in the car through an open window.** He claimed he was teaching Linda to drive when police contacted them. Tremaine admitted to having possessed the firearm and **told me he was a convicted felon.** Tremaine said he had previously stolen other cars but "this was the first time I was caught". He said he had been driving most of the time since he stole it and picked Linda up in Seattle shortly afterwards. They had been at the Muckleshoot Casino last night and were resting before returning to Seattle, where they planned to dump the car. Linda was going to drive.
